### SECTION 3: HEALTH AND WELFARE

The Breeder has taken every care with breeding, rearing and the welfare of the Dog. The Dog is believed to be in good health and it is sold in good faith. The Breeder makes no warranty however as to the health or disposition of the Dog.

Every effort has been made to avoid any possible inherited conditions. Conditions known/thought to be inherited in the breed are: Hip dysplasia

Relevant screening has been done

The puppy has been inspected by a practising veterinary surgeon prior to sale and the details of the veterinary surgeon and the outcome of the inspection have been passed to the purchaser.

The purchaser agrees to also have the puppy inspected by a veterinary surgeon within 3 days of purchase, for a general check and advice on inoculations and worming, and agrees to provide the breeder with the details of the veterinary surgeon and the outcome of the inspection.

The purchaser agrees and confirms they will give this puppy every care and attention according to its needs and that you will have:

- a) The puppy vaccinated annually by a Registered Vet or Vaccination Clinic, or follow a specific vaccination program as prescribed by a BVA Registered Vet.
- b) Wormed at least every 6 months and have any other treatment that may be recommended by a vet for health and wellbeing of this puppy
- c) You further understand that if there is a failure to keep any part of this contract, or if the puppy is neglected, maltreated or is failing to receive adequate and proper medical care, you will immediately surrender said puppy to the breeder unconditionally and without financial restitution or compensation, along with all registration documentation (signed appropriately to return ownership to the breeder) all vaccination and veterinary treatment records including all health testing result certificates.

### SECTION 4: PURCHASER'S RIGHT TO RETURN THE DOG IN THE CASE OF A DEFECT

The Purchaser(s) shall have 3 days to have the Dog examined by a practising veterinary surgeon and shall have the right during a period not exceeding 3 days after such examination to return the Dog because of a defect (other than described below) on production of a written report from the said veterinary surgeon, at which time the Purchaser(s) will be refunded the full purchase price.

The Purchaser(s) hereby acknowledge(s) that the Breeder has disclosed the following faults or defects in the Dog:

Should it become necessary, the Purchaser(s) should be aware that the return of a Dog can be very difficult, especially emotionally and, having drawn the attention of the Purchaser(s) to this, the Breeder cannot be held responsible for any distress caused by the return of the Dog.

### SECTION 5: POTENTIAL OF DOG

Although any description of the Dog as being of show or trial quality is given in good faith, it is a condition of this sale that no warranty can be given as to the ultimate show / working / field trial or breeding potential on maturity of the Dog.

## SECTION 6: ENDORSEMENTS

This Dog is subject to the following Kennel Club endorsements: (R) Progeny Not Eligible for Registration and Not Eligible for Issue of Export Pedigree

Endorsements can only be lifted by the person who placed them, and that person would need to send a written & signed instruction to this effect to the Kennel Club.

Endorsement R (progeny not eligible for registration) will only be lifted on the following conditions:

- a) Production of satisfactory written evidence from the BVA or SV that [Dog's Name] has been hip scored in accordance with the KC/BVA or SV Scheme and that the total hip score for this puppy is no greater than the current breed average.
- b) Production of satisfactory written evidence from the BVA or SV that [Dog's Name] has been elbow scored and is no higher than a total of 0
- c) That this puppy is considered by the breeder or nominated representative to be a good example of the breed.
- d) That this puppy is of sound temperament.
- e) Is not suffering from or being treated for any disease or condition that may affect or be inherited by his/her offspring.
- f) The dog must be at least 18 months for a male or 2 years for a female at the time of mating.

Please refer to the breeder for advice. These conditions are in place to help to protect this puppy.

## SECTION 7: REHOMING OF THE DOG

The Purchaser(s) agree that if, at any stage in the Dog's life, the Purchaser(s) need to rehome the Dog, the Breeder will be the first to be informed and the Purchaser(s) will, if the Breeder requests, return the Dog to the Breeder. The Breeder will offer every reasonable assistance to find a new home.

# Endorsements

## Important notice

**Kennel Club registration may be endorsed  
Future breeding - registration of puppies not permitted (R)  
Export pedigrees not available for export registration (X)**

The registered owner of a dog may place the following endorsements on a dog's records:

**R = Progeny not eligible for registration**

– which means any puppies bred from the dog will not be accepted for registration by The Kennel Club

**X = Not eligible for the issue of an Export Pedigree**

– which means The Kennel Club will not provide the pedigree required for export and registration at an overseas kennel registry.

The new owner **must** sign to confirm that they have been made aware of the endorsement(s), at or before they take possession of the dog. **The form must be signed by someone over 18 years old.** If the owner is under 18, a parent or guardian must sign on their behalf. Providing that the endorsement has been placed in accordance with Kennel Club Regulation B12, The Kennel Club will not become involved in any dispute arising from a private transaction.

**A copy of this notice must be given to the new owner and a copy must be retained by the endorser.**
